


Figure 1: Schematic Diagram Of Social Elements




Figure 2: Diagram Of Information And Communication System

The main function of the transmission device is to convert the information transmitted by the information source the appropriate into information form transmitted in channel by amplifying the signal and transform spectrum. Channel refers to transmission media which has the shape of wireless and wired. The function of receiving equipment is contrary to the function of sender. Information sink is the terminal of information. Interference sources occur in the various aspects of the communication system which is unavoidable.

2.2 The Concept Of The Amount Of Information

The amount of information is the main object of information and communication technology, which refers to the number of information. The amount of information I and probability of information appeared P(x) has a function relationship: When the information probability increases, the amount of information will be reduced. On the contrary, when the information probability decreases, the amount of information will increase. Function relationship is[5]:

With the continuous development of modern information and communication technology is increasingly important in the development and progress of science and technology. 3.2 Contrast Between Modern English Teaching And Traditional English Teaching

After we get the matrix list, we can calculate the weight set of main factors based on the MATLAB software is A=[0.5716,0.2854,0.1425]. We can get B=[0.1796,0.3325,0.2374,0.2493] through the substitution of A=[0.5716,0.2854,0.1425] into the above model. We can see from the results that information and communication technology is superior to the traditional English teaching methods in modern English teaching. Of course, traditional teaching methods cannot be completely denied, and the effect of the effective combination of the two will be more obvious.

Information and communication technology represents a new multimedia technology which includes computer software, CD-ROM, Internet, mobile phone, TV, movies and Internet based on project work, email, chat, blogs, wikis, podcasts, etc. A large quantity of studies have been done that, information and communication technology has better effect in the use of language on students' language learning and understanding, it also increase the enthusiasm of the students and achievement in the use of information and communication technology[9,10]. We can get evaluation matrix of information and communication technology which is shown as follows[15]:

When we determine index weight coefficients of various impact factors, we can analyze the judgment result of the information and communication technology carried according to the weight coefficient of the judged level. For the N judged levels, we can divide the interval average. When N is 4, the four intervals are [0,0.25][0.25,0.50][0.50,0.75][0.75,1.0]. We can

When $\xi_j \in [a_i, b_j]$, evaluation results of a_i is $\frac{d_{ij}}{k}$. Judgment result set is $\{C_1, C_2 \dots C_n\}$.

In short, the positive potential community of information and communication technology in the teaching of English in the technology and materials has been fully recognized, but the lack of the effective integration of information technology into the teaching reform of current uses and sustains in training teachers, so we must strengthen the information technology application in English teaching, in order to enrich the learning environment, improve the classroom efficiency, improve the quality of teaching, cultivate students' interest in the classroom and the learning initiative, and lay a solid foundation for English teaching.
